All guests must be no older than 20 years of age the night of the dance, **NO** exceptions. Middle school students are not allowed to attend. All students wishing to attend the dance with a Non-Capistrano Valley High School guest must fill out and submit this form and abide by the following set of criterion. **All guests must read and sign this form.**

- PLEASE PRINT LEGIBLY OR YOUR CONTRACT WILL NOT BE PROCESSED.
- Signature of approval by an administrator from the guest's high school, ALONG WITH THE BUSINESS CARD OF THE ADMINISTRATOR SIGNING.
- **All guests must ATTACH a CLEAR photocopy of the guest's picture ID** from their current high school or their driver's license for non-high school students. The photo ID must verify the age of the guest.
- All guests must read and sign the behavioral commitment on the back of this form describing all the behavioral expectations at CVHS events. Parent of CVHS student and guest (if applies) must also sign the back of this form.
- **CVHS student:** Check list outside of Activities for any debts/detention. These must be paid/cleared before purchase.
- All signatures will be verified and any forgery will result in not being able to attend the dance.
- Guest tickets must be purchased by 3:00pm on Friday, April 29, 2022. Please see pricing below.

THE NIGHT OF THE DANCE:

- Everyone must have a picture ID to get into the dance. The dance begins at 8:00 PM
- All attendees must arrive by 9:00 PM and all guests must arrive with their sponsor.

GUEST BEHAVIORAL COMMITMENT Prom 2022

1. **The 2022 Prom will be held Saturday, April 30, 2022, at the The Bowers Musuem, Sant Ana. The dance begins at 8:00PM and ends at 11:00PM.** NO STUDENT WILL BE ADMITTED AFTER 9:00PM UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE WITH ACTIVITIES DIRECTOR. NO STUDENT WILL BE ALLOWED TO LEAVE THE DANCE BEFORE 10:00PM. Student/guest must be picked up no later than 11:00 PM. Student/guest who leaves the dance will not be readmitted.
2. Student/guest who consumes alcohol or any illegal substance before or during the dance will be removed, their parents will be called to escort the student/guest home, and the student may be recommended for expulsion according to Board policy.
3. Student/guest will be checked for illegal or controlled substances. . We reserve the right to search and **ALL ATTENDEES WILL BE BREATHALYZED.** Sheriffs will be called if applicable.
4. Inappropriate conduct/dancing will result in the removal from the dance and possible further disciplinary action. If inappropriate conduct/dancing is widespread the music will be turned off for a period of time and/or the dance will be ended. No refunds will be given.
5. Loud music and lighting effects will be in use. It is the responsibility of the attendees to protect themselves from any auditory and/or visual sensitivity.
6. Trading or selling bids is NOT ALLOWED.
7. R.V's, campers, buses or other recreational vehicles are not allowed to be driven to the dance. Any vehicle, including limos and charter buses, may be searched. If you are planning on taking a charter bus/limo (over 15 passengers), you must get a bus contract from activities and turn it in no later than Wednesday, April 27 by 3pm.
8. All students **must** present their CVHS ID at the registration table. (Student ID or Driver's License for outside guests).
9. Students/guests who are dismissed from dance may not be permitted to attend future dances and are subject to exclusion from future co-curricular and extra-curricular activities (including graduation).

DRESS CODE – FORMAL DANCE

Formal attire is required for Prom. All students must always wear a shirt and pants; or the equivalent, or a dress or skirt and shoes. Violation(s) may result in non-admittance in which case parents will be called to pick up the student, or bring appropriate attire. If a dress code violation is noticed or occurs after admittance, student/attendee may be removed from the dance. If an attendee has a question about the appropriateness of his or her attire, please consult with an Assistant Principal prior to the event and/or go to www.cvhs.com.

Students must wear:

- **A collared shirt with sleeves, slacks and tie apparel**
- **Pants, no jeans, or a dress or skirt**
- **Shoes, appropriate for the environment and activity**

Students MAY NOT wear:

- **Items that contain offensive, illegal, violent, obscene symbols, signs, slogans, or words degrading any gender, culture, religion, ethnicity, race or anything that may incite a negative response or conflict including references to sex, drugs, alcohol or tobacco.**
- **Clothing or accessories considered unsafe, dangerous or a health hazard**
- **No clothing that significantly and/or intentionally reveals undergarments**
- **No items that obscure the face, except as a religious observance**
