## California starts school year with a record-setting education budget

This will be a school year the likes of which none of us has ever known.

On the one hand, schools will face the challenge of keeping children and staff safe as the COVID pandemic continues. They will implement programs to help children overcome the academic shortfalls and mental health struggles they may have experienced during the past year.

On the other hand, schools will be supported by the largest education budget in state history, with \$123.9 billion designated for pre-kindergarten through high school. For the first time in decades, California will likely be above the national average in per-pupil spending.

“This education package is great news for students and families in California,” said Carol Green, President of California State PTA. “It includes funding for top PTA priorities including early childhood education, community schools and wrap-around services, universal school nutrition, and mental health services. PTA also supports the return to in-person instruction that includes a robust option for students who may need distance learning for health or other reasons.

“We are also thrilled with the investment in universal transitional kindergarten for all four-year-olds by 2025.” Green added. “California State PTA has been advocating

for this for years. We know this will go a long way toward closing opportunity and achievement gaps for future generations.”

The record-setting budget is the result of unexpectedly high state tax revenues and \$25 billion in federal assistance.

This will be an important year for PTA members to stay informed about how their district and schools are spending this money. Is it being used to assist the students who need help? Is it being spent equitably?

Look for information on your school district website. Your district’s Local Control and Accountability Plan (LCAP) for 2021-24 should be posted there. Ask your principal for information at your unit meetings. Invite the superintendent to present reports at PTA council meetings (if she or he doesn’t already do so). Attend school board meetings and be prepared to provide input when needed. Get involved in your school district’s [LCAP process](#) to help decide how the funding will be spent in upcoming years.

## September 14 is the last day to vote in the state recall election

Voting in the statewide recall election is underway. Every registered voter in Orange County should have received a vote-by-mail ballot from the Orange County Registrar of Voters. If you did not receive your ballot, contact the Registrar at (714) 567-7600.

Completed ballots must be mailed or returned to the Registrar’s office, or deposited in an official [Ballot Drop Box](#) by September 14.

If you prefer to vote in person, Vote Centers will be open September 4 through 14. Go to the Registrar’s [website](#) for locations and more information.

There are two questions on the ballot:


1. Do you want to recall the governor (remove him from office)?

2. If the governor is recalled, who do you want to replace him?

If more than 50 percent of voters say “no” to the first question, the governor remains in office.

If more than 50 percent of voters say “yes” to the first question, the person who gets the most votes on the second question becomes the governor. A replacement candidate does NOT need more than 50 percent of the votes to win; he or she simply needs more votes than any of the other candidates. No matter how you answer question one you can still vote for a replacement candidate.

You don’t need to answer both questions. You can answer just the first or second question, or both. It’s your choice. Your vote will be counted either way.

"Data needs to be part of advocacy," she says. "It's not just sharing what we want and need, it's also making the case with information."
